

Release & Consent Form

Blick Art Materials, LLC (“Blick” or “we”) takes pride in supporting local artists, be they professional artists, hobbyists, students, or employees. As a retail store, we must impose certain limitations and conditions on the display of artwork at our stores, listed below:

- As a retail store, the display of art and installations (“Work”) on our premises is done at the artist’s own risk. All Work will be entrusted to Blick and its employees for the purpose of hanging and display, and artist assumes all risks attendant to such actions; Blick shall not be responsible to the artist for any incidents naturally arising from the hanging and display of Works. If any Work is lost or completely destroyed, determined at Blick’s sole discretion, Blick’s maximum liability, if any, shall be \$250.
- Blick reserves the right to refuse to handle or display any Work. The artist is responsible for any matting, framing, or any other presentation needs. Works that are not properly presented and ready to hang will not be displayed. All work must be completed and presented at the time of hanging—subsequent pieces will not be accepted.
- Works will generally be displayed for a time period agreed upon by the artist and the store management; however, management may shorten or end such period at any time and for any reason. Works will not be removed at the request of the artist for any reason during the agreed time frame without Management’s prior written approval.
- All art pieces must be removed from the store within fourteen (14) days after the agreed time frame for display ends. The artist agrees that Works not retrieved by then have been abandoned and will become property of Blick. Blick may dispose of such Works at its sole discretion.
- Any sales of Works displayed in a store and all transactions related to the same are to be handled by the artist. Blick welcomes artists to provide a notecard containing information identifying the Work to be displayed, the artist’s name and contact information, and, if applicable, a retail price for the Work. Even if sold, no Works will be removed from display before termination of the agreed time frame. Any delivery arrangements related to the sale are the responsibility of the artist.
- In exchange for the opportunity to display a Work, the artist grants a non-exclusive, non-revocable license in perpetuity for Blick to use photographs containing full or partial renderings of the Work in Blick’s promotional materials and advertising.
